Mollib is a *unified* command-line program and Python library for the validation, quality analysis and manipulation of molecular structures with an emphasis on biophysical analysis. Mollib is built on a plugin framework to easily add new tools to manipulate and analyze structures and data, which can then be *combined* and *cross-validated*.

#### Mollib includes tools for:

- The *processing* and protonation of molecules.
- The analysis of *hydrogen bonds* and hydrogen bond quality compared to the highest-resolution PDB structures. Hydrogen bonds are classified based on their acceptor-donor residues and Ramachandran angles
- The *measurement* of geometries within molecules as well as the reporting and classification of Ramachandran angles.
- The statistical analysis and comparison of structures to high-resolution crystal structures.
- The analysis of *partial alignment* data with residual dipolar coupling (RDC) and residual anisotropic chemical shift (RACS, a.k.a RCSA) data.

#### Installation

\$ pip install mollib

Note: Python and pip may not be installed. You may need to download and install Python first.

# CHAPTER 1

# Command Line Interface

## 1.1 Overview

The command line interface includes all of mollib's functions for processing and analyzing molecules and molecular data. Mollib can be accessed either through the mollib or ml commands.

- -h/--help Get basic help information on usage of the command line interface, or one one of the mollib commands.
- -d / --debug Display debug messages to the terminal. This is usually only useful to developers or in helping to debug issues.

- **-s / --suppress** Display only errors and critical errors.
- -v/--verbose Display informational messages to the terminal. By default, only warning and error messages are displayed.
- **--version** Display the version number of the installed mollib.
- **--list-plugins** Display a list of installed and enabled plugins.

--list-settings Display a list of the settings sections that will be interpreted from configuration files.

# 1.1.1 Configuration Files

Mollib will check for a .mollibrc configuration file and a configuration file passed with the -c filename / --config filename commandline argument for configuration parameters.

Configuration files customize mollib's behavior from default values. If a .mollibrc file is present and a configuration file is specified in the commandline, the commandline configuration file will take precedence for parameters that are mentioned in both.

The following is an example configuration file. Note that only the parameters that need to be changed can be specified in the file.

# 1.2 process command

The process command is the main command for processing, reading and writing files. All of the options and preprocessors available in process are available to other commands.

# 1.2.1 Arguments

-i/--in id/filename (required) One or more structural identifiers (ex: PDB file identifiers) or filenames to load.

If the structure could not be found locally, a copy will be downloaded and cached for further analysis.

Multiple input identifiers and filenames can be used to process multiple files simultaneously.

**-o/--out filename** The output filename(s).

Structure files that are written have passed through the mollib parser and will likely not be identical to the original files. Changes may have been done to the atoms, header comments or other aspects, depending on which preprocessors were used.

Multiple output filenames can be used, and these will be matched to the corresponding entries in the input filenames or identifiers.

- -c/--config filename The configuration file. See *Configuration files* for more details.
- **-s / --save** Save fetched files from the internet to the local directory.

- -m/--models The specific model numbers to load. By default, only the first model is loaded.
- **-1** List details on the molecule, including the number of chains, residues and atoms. This option is helpful in determining selections in *Abbreviated Selectors*.

## **Preprocessors Arguments**

**--hydrogenate** Strip all hydrogen atoms and re-add hydrogens based on ideal geometry. More details on the current implementation can be found in the API documentation *Hydrogens Module*.

**Note:** Adding two hydrogens to an sp2 heavy atom will label the E-hydrogen 'H1' and the Z-hydrogen 'H2'. This situation happens with the HD2 hydrogens of asparagine residues, for example.

**Note:** Adding two hydrogens to an sp3 heavy atom will label the pro-R hydrogen 'H2' and the pro-S hydrogen 'H3'. Some exceptions in proteins exist. By default, the JBNMR 12, 1-23 (1998) convention is followed.

## 1.2.2 Examples

The following example loads a crystal structure of ubiquitin from the PDB (-i 1UBQ), adds hydrogens to the molecule (--hydrogenate) and saves the output to a new file (-o 1UBQ\_H.pdb).

#### 1.3 measure command

The measure command is used for measuring geometries in molecules. All of the options and preprocessors available from the *process command* are also available.

### 1.3.1 Arguments

-d/--dist atom atom Measure the distance (in Angstroms) between two atoms.

Multiple atom pairs can used. ex: -d 31.N 31.CA -d 32.N 33.CA

Atoms must follow the standard naming conventions. See Abbreviated Selectors and Filters.

**-a / --angle** Measure the angle (in degrees) between three atoms.

Multiple atom triplets can be used. ex: -a 31.N 31.CA 31.CB -a 32.N 32.CA 32.CB

Atoms must follow the standard naming conventions. See *Abbreviated Selectors* and *Filters*.

-dih/--dihedral Measure the dihedral angle (in degrees) between four atoms.

Multiple atom quartets can be used. ex: -dih 30.C 31.N 31.CA 31.C -dih 31.N 31.CA 31.C 32.N

Atoms must follow the standard naming conventions. See Abbreviated Selectors and Filters.

**Note:** If simple Ramachandran dihedrals are needed, checkout --rama.

- **--stats** Report the average and standard deviation of all measured values. This option only applies to the distance, angle and dihedral measurements.
- **--rama** Measure Ramachandran angles (in degrees) for a protein. Filters and options are ignored. Heteroatom chains are skipped.

The --rama command classifies Ramachandran angles based on backbone-backbone amide hydrogen bonds.

#### 1.3.2 Atom Selectors and Filters

#### **Abbreviated Selectors**

The measure methods find atoms using atom locators. Atom locators must follow one of these conventions:

- 1. (residue number).(atom name). ex: 31.CB for the CB atom of residue number 31.
- 2. (chain id).(residue number).(atom name). ex: A.31.CB for the CB atom of residue number 31 in chain 'A'.

Additionally, the chain id, residue number or both can be expressed as a range using the ':' character:

- 1. (residue range).(atom name). ex: 31:34.CB for the CB atom of residue number 31, 32, 33 and 34.
- 2. (chain range).(residue number).(atom name). ex:A:C.34.CB for the CB atom of residue number 34 for chains 'A', 'B', 'C' and 'D'.

Finally, heteroatom chains have an asterisk appended to them. ex: 'C\*'

**Note:** Atom selections may encompass hundreds of atoms, which when used in combination, could lead to searches over millions of combinations. To help improve their performance, you can either narrow their scope by reducing the range of chains or residue numbers, combine multiple *Filters* or use one of the shortcut selectors, like --rama for Ramachandran dihedral angles.

#### **Filters**

- **--only-intra** Exclude atom selections that are *not* within the same residue.
- **--exclude-intra** Exclude atom selections that are within the same residue.
- **--only-intra-chain** Exclude atom selections that are *not* within the same chain.
- **--exclude-intra-chain** Exclude atom selections that are within the same chain.
- --only-delta DELTA Exclude atom selections that don't have at least one set of atoms with residues separated by DELTA number. This filter ignores the chain identifier and may need to be combined with --filter-intra-chain or --exclude-intra-chain.
- **--only-bonded** Exclude atom selections that are not bonded. The bonded tests linear bonding relationships. For example, a dihedral with four atoms (atom1, atom2, atom3 and atom4) must have bonds between atom1–atom2, atom2–atom3 and atom3–atom4.

**Note:** Bonded searches have to investigate the topology of each atom selection, which can be slower than the above filters. Combining the --only-bonded filter with other filters, like --only-delta 1, can significantly speed up searches.

## 1.3.3 Examples

#### **Measuring distances**

Measure  $\alpha$ -helical HA-H distances in chain 'A' for residues 23-49 of 2MUV, the homotetrametic influenza M2 channel. Include statistics on the measured distances.

Compare the distance between the HA of residue 5 and the H of residue 21 for two different structures, 2KXA and 2LWA. The 2KXA structure represents the wildtype hemagglutinin fusion peptide (HAfp) in the *closed* helical-hairpin structure, placing these two atoms in close promixity. The 2LWA structure represents the conformational ensemble of the HAfp-G8A mutant with a closed structure (chain 'A'), a semi-closed structure (chain 'B') and an open structure (chain 'C').

#### **Measuring Angles**

Measure the angle of the bonded 'C-1'-'N'-'H' atoms for residues 20-30 from the ubiquitin structure 2MJB.

### **Measuring Dihedrals**

The following example measures the  $\phi$  angle for residues 2-6 of the hemagglutinin fusion peptide domain (2KXA).

## **Ramachandran Angles**

Measure the Ramachandran  $\phi$  and  $\psi$  angles for the hemagglutinin fusion peptide structure 2KXA.

# 1.3.4 Approach to Secondary Structure Assignments

#### **β Turns**

Turns are defined by a hydrogen bond between residues 'i' and 'i+4' as well as the backbone torsion angles for residues 'i+1' and 'i+2'. The turn type is based on the torsion angles of the 'i+1' and 'i+2' residues.

Assignments of the turn residues 'i+1' and 'i+2' are made. However, since the torsion angles of the terminal residues–specifically  $\phi$  of residue 'i' and  $\psi$  of residue 'i+4'-are flexible, these are not included in the assignment.

#### Helices

Helices consist of stretches of hydrogen bonded residues with helical dihedrals. 310-helices are typically short, with one or more 'i'-'i+3'hydrogen bonds, and these can be mischaracterized as turns (type I turns). In this case, mollib checks that all residues in the helix have helical dihedral angles.

#### **Sheets**

Sheets are first identified by finding hydrogen bonds between residues with sheet torsion angles. This process identifies most sheet residues. However, for strands on the edges of sheets, every second amino acid may not form an internal hydrogen bond.

To accurately identify sheet strands, mollib will find groups of sheet hydrogen bonds, then it will evaluate whether the residues are in a checkered pattern and whether the previous or subsequent residues have sheet backbone torsion angles. Thereafter, it will assign all residues in the group to a sheet classification, if no other classification has already been made. See *assign blocks* for details.

#### **Assign Blocks**

Secondary structure assignments are made based on hydrogen bonds. In some cases, such as the edge strands of sheets or short 310-helices, residues within a contiguous block are not assigned because they do not form an internal hydrogen bond. Mollib assign contiguous blocks of residues with the same secondary structure by testing the dihedral of residues within that block and filling gaps in assignment.

For example, a checkered sheet assignment ('E E E E') will be assigned as a single contiguous β-strand ('EEEEEEEE') if all residues in the block have β-strand backbone dihedral angles. 310-helices are another example in which the 'i' and 'i+3' residues are hydrogen bonded, yet the 'i+1' and 'i+2' residues may not be. In this case, the gap will be filled by assigning residues 'i' through 'i+3' as 310-helix, if all four residues have helical dihedral angles.

Additionally, assigning blocks will label the minor classification of N- and C-terminal residues for certain secondary structure blocks, depending on the settings.

**Note:** The identification of the 'N-term' and 'C-term' minor classifications are done separately for residues and hydrogen bonds. These assignments may be different between residues and hydrogen bonds.


#### **Energy Maps**


The backbone dihedral probabilities and energies are calculated from potential of mean force plots for each type of secondary structure. It is calculated from the probability of finding a particular set of dihedral angles in a group of high-resolution structures. A high probability indicates that the measured dihedral angles are observed frequently in high-resolution structures. Conversely, a low probability indicates that a particular set of dihedral angles is rarely seen in high-resolution structures. These are typically colored in yellow (relatively rare) or red (very rare).

The energies represent a potential of mean force (PMF) calculated from a Boltzmann inversion.

$$E(\Omega) = -kTln[P(\Omega)]$$

The energy is zero when a set of dihedrals angles is optimal for a given type of secondary structure classification. The following are the energy plots for each secondary structure classification.





## 1.4 hbonds command

The hbonds command detects and reports hydrogen bonds in molecules. The hbonds command has the following features:

- It identifies hydrogen bonds between backbones, sidechains, subunits and ligands.
- It has a flexible interface to identify a wide-range of hydrogen bond types including *amide*, *aliphatic*, *hydroxyl* and the specification of arbritrary electric dipole types.
- It classifies backbone-backbone hydrogen bonds based on backbone torsion angles.
- Helical stretches require contiguous residues with helical backbone torsion angles. This prevents the misclassification of 310-helices and beta turns as well as isolated i+3, i+4 and i+5 hydrogen bonds.

**Note:** If the molecule does not have hydrogens, this command will need to be run with the --hydrogenate parameter. See the *hydrogenate* option.

1.4. hbonds command

## 1.4.1 Arguments

- **--aliphatic** (Optional) Include aliphatic hydrogen bonds in the results. The acceptor-donor atom cutoff distances are elongated to 3.0 A, and carbon atoms are allowed in hydrogen bond donor dipoles.
- **--detailed** (Optional) Present a detailed report on the geometries of hydrogen bonds. The detailed table does not include classification information.
- **--sort-type** (Optional) Sort the hydrogen bonds by classification type, like beta-sheet or alpha-helix.

## 1.4.2 Examples

In this example, the hemagglutinin fusion peptide structure (-i 2KXA) is downloaded, and its amide hydrogen bonds are reported.

## 1.4.3 Theory

Hydrogen bonds are defined between a donor dipole, which includes a hydrogen atom, and an acceptor dipole. The acceptor and donor dipoles are more than simple electric dipoles. The electric dipole-dipole energy is minimized when the two dipoles are aligned colinearly (head-to-toe) with respect to each other. Hydrogen bonds involve the sharing of a hydrogen atom between a donor atom (N) and an acceptor atom (O) and the distribution of electron density between these atoms and the hydrogen atom. Consequently, hydrogen bonds are arranged according to the molecular orbitals between the donor and acceptor atoms, rather than simply the electric potential between atoms. As a result, optimal hydrogen bonds are askew from a standard electric dipole.

#### Geometry

A hydrogen bond has an acceptor dipole and a donor dipole. The donor dipole has a d1 donor atom (H) and a d2 donor atom (N, O or C), and the acceptor has an a1 acceptor atom (O) and an a2 acceptor atom (C). The geometry of a hydrogen bond is defined by the distance of the d1a1 vector  $(d_{d1a1})$ , the  $\theta$  angle and the  $\phi$  angle.

- $d_{d1a1}$  distance (in Angstroms) The distance between the d1 donor atom (H) and the a1 acceptor atom (O).
- $\theta$  angle (in degrees) The angle between the d1a1 vector and the z-axis of the acceptor dipole. The z-axis of the acceptor dipole is defined by the normalized vector formed between the acceptor a1 and a2 atoms.
- $\phi$  angle (in degrees) The angle between the d1a1 vector and the x-axis of the acceptor dipole plane. The acceptor dipole plane is defined by the the acceptor dipole atoms and the next heaviest atom bound to atom a2.

#### **Energy and Probabilities**

The reported probabilities are determined from a histogram of the  $d_{d1a1}$  distance, the  $\theta$  angle and the  $\phi$  angle compared to a set of ca. 11,300 high-resolution crystal structures in the PDB. A high probability indicates that the measured hydrogen bond geometries are observed frequently in high-resolution structures. Conversely, a low probability indicates that a particular hydrogen bond geometry is rarely seen in high-resolution structures. These are typically colored in yellow (relatively rare) or red (very rare).

The energies represent a potential of mean force (PMF) calculated from a Boltzmann inversion.

$$E(\Omega) = -kTln[P(\Omega)]$$

The energy (in units of kT) is calculated from the Boltzmann constant and temperature (kT) and the probability of finding the specific configuration,  $\Omega$ . The configuration, in this case, is defined by the  $d_{d1a1}$  distance, the  $\theta$  angle and the  $\phi$  angle. The energy is 0 for an ideal hydrogen bond, and it increases as the hydrogen bond deviates from ideality–according to the probability of finding a specific geometry in high-resolution structures.

# 1.5 pa command

The pa command is used to fit residual dipolar couplings (RDCs) and residual anisotropic chemical shifts (RACSs, sometimes known as RCSAs) from *partially aligned* samples using NMR. The output table entries are colored for warning outliers (yellow) and bad outliers (red).

## 1.5.1 Arguments

- -d/ --data filename The file(s) with the RDC and RACS alignment data. These can be in either of the following formats:
  - The mollib data format. See Partial Alignment Data File Format.
  - NMRPipe's DC format.
  - Magnetic resonance data files (.mr) in Xplor format submitted to the PDB. This function supports the automatic fetching and caching of magnetic resonance data files.
- -o/ --out filename (Optional) The filename for the output report. The output report is rendered in Markdown.
- **-p/--pred filename** (Optional) The filename for the back-calculated RDCs and RACS from the SVD fit. The output report is rendered in Markdown.
- --summary (Optional) Only display the fit summary.
- --exclude interactions-types (Optional) Exclude one or more interactions types. ex: --exclude N-H CA-HA will exclude all N-H and CA-HA RDCs.
- **--set id** (Optional) Use the given data set, if multiple data sets are available. This option is useful with .mr data from the PDB, which may contain multiple alignment data sets from multiple alignment media. Sets can be selected from their alignment tensor value (ex: 500, 501, etc) or from their position within the data file, starting with 0. (ex: 0 for the first dataset, 1, for the second dataset and so on.) By default, the first dataset is used.
- **--project-methyls** (Optional) Use the C-C bond RDC values for the methyl <sup>1</sup>H-<sup>13</sup>C RDCs. This is the convention followed by X-plor NIH. By default, this is disabled.
- **--methyl-scale number** (Optional) The scaling constant to use in fitting the methyl RDCs. This scaling may be needed if the contribution of the C3-rotational motion was not accounted for in the reported RDCs. By default, this value is 1.0.

**Note:** The models option (-m/--models) will load the models as multiple molecules to be fit together in the SVD rather than conduct a separate SVD for each.

#### **Fixer Arguments**

- --fix-sign/--nofix-sign (Optional) Check to see if the sign of RDCs or RACSs of the same type need to be inverted to get a better fit. This operation is useful for automatically fixing the sign of couplings when the absolute value of the IJ+DI- and IJI-couplings are used. By default, this fixer is on.
- --fix-outliers / --nofix-outliers (Optional) Check to see if there are outliers for each type of interaction. A warning outlier and a bad outlier are defined by those that give an alpha-critical cutoff of 95% and 99%, respectively, using a Grubbs test. If outliers are found, these will be removed from the fit and the reported statistics. By default, this fixer is off.
- --fix-nh-scale / --nofix-nh-scale (Optional) Check to see if RDCs and RACSs have been scaled to match the magnitude of N-H RDCs. If they have, scale them back down to their original values. By default, this fixer is off.

## 1.5.2 Partial Alignment Data File Format

The file format has the following features:

- 1. The interaction labels for dipolar interactions refer to two atoms (ex: 14N-H) and the interaction label for CSA interactions refer to one atom.
- 2. For dipolar interactions, redundant residue numbers and chain identifiers are not needed. For example, '14N-H' and '14N-14H' refer to the same dipole.
- 3. If the chain identifier is not specified, then the subunit 'A' is assumed.
- 4. Relative residue numbers are allowed. For example, '14N-C-1' is the same as the '14N-13C' dipole.
- 5. Errors are optional. If the error is not specified, a default value from the settings is used.

#### 1.5.4 Tensor Conventions

In the absence of motion, dipolar tensors are axially symmetric (i.e.  $\delta_{xx} = \delta_{yy}$ ) and the principal component ( $\delta_{zz}$ ) is colinear with the internuclear vector in the principal axis system (PAS).

Chemical shift tensors (CSA) may be axially asymmetric (i.e.  $\delta_{xx} \neq \delta_{yy}$ ), and their geometries must be specified in relation to internal atomic coordinates. We use the convention from Cornilescu *et al.* [Cornilescu2000].

The literature reports both the chemical *shielding* tensor  $(\sigma)$  and the chemical *shift* tensor  $(\delta)$ . The difference between the two is an inversion of sign (i.e.  $\sigma = -\delta$ ). As a result, the ordering of components between different conventions will change. In the Haeberlen convention, the chemical shift components are ordered by their magnitudes.

$$|\delta_{zz}| \ge |\delta_{xx}| \ge |\delta_{yy}|$$

The isotropic component ( $\delta_{iso}$ ) has already been subtracted from the three components.

$$\delta_{iso} = \frac{1}{3} \left( \delta_{zz} + \delta_{xx} + \delta_{yy} \right)$$

In the IUPAC convention, the components are normally ordered starting from the largest component (with sign) as the '11' component. However, for chemical *shielding* tensors, the '33' component is largest.

$$\sigma_{33} > \sigma_{22} > \sigma_{11}$$

Mollib uses the Haeberlen convention and chemical *shift* tensors. The backbone H, C' and N CSA tensors are defined as follows:

The  $^{13}\text{C}$ ' tensor (blue) has the largest component  $(\delta_{zz})$  oriented orthogonal to the O-C-N plane, and it is rotated about this component by the  $\alpha_z$  angle.

The  $^{15}$ N tensor (red) has the largest component ( $\delta_{zz}$ ) nearly colinear with the H-N bond, and it is rotated away from the bond about the yy-component (orthogonal to the H-N-C' plane) with an angle  $\beta_{y}$ .




Fig. 2: Backbone CSA tensor conventions

The <sup>1</sup>H tensor (green) has the largest component ( $\delta_{zz}$ ) nearly colinear with the H-N bond, and it is rotated about the xx-component (orthogonal to the H-N-C' plane) by an angle  $\gamma_x$ .

Recipes

# 2.1 Command-line Tips and Tricks

### 2.1.1 Shell Aliases and Functions

The following aliases are helpful in reducing typing on the command line. These can be added to the user shell script (ex: .bashrc).

# 2.2 Python Recipes

# 2.2.1 Loading a Molecule

A molecule can be loaded directly from molecule objects. The following will automatically download the file, cache it and read in the PDB for the structure '2kxa'.

# 2.2.3 Accessing Chains, Residues, Atoms and Coordinates

Molecules, chains, and residues are extented dict objects. Chains are accessed by chain id (ex: 'A'), residues are accessed by residue number (ex: 3), and atoms are accessed by atom name (ex: 'CA').

### 3.1.4 CLI Features

The command-line interface (CLI) includes a series of plugins for processing and analyzing molecular structures.

#### process

- The process command plugin is used to read molecular structures and modify them.
- Currently supports the loading of protein databank (PDB) files as well as the fetching and caching of PDB files from the internet.
- The hydrogens plugin (--hydrogenate) is included to strip and replace hydrogen atoms in a molecule. The topology of protein molecules are included and the CONECT topologies in PDB files are supported.
- Individual models or many models can be selected.

#### measure

- The measure command plugin is used to measure interatomic distances, angles and dihedrals in molecules.
- Statistical summaries of measurements are available with the --stats option.
- Ramachandran angles are calculated with the --rama option. The Ramachandran angles include secondary structure assignments based on the backbone dihedral angles and hydrogen bonding pattern, like DSSP.
- Statistics on the frequency of the observed Ramachandran angles for the given secondary structure type are provided. Statistics are calculated from the highest resolution structures from the PDB. (Unique structures with resolutions between 0.5-1.6Å, observed R-factors better than 0.25 and free R-factors better than 0.30.)

#### **hbonds**

- The *hbonds* plugin is used to measure and rate amide and aliphatic hydrogen bonds in structures.
- Hydrogen bonds are classified based on backbone torsion (Ramachandran) angles and the acceptor-donor position in the primary sequence.
- Statistics on the frequency of observed hydrogen bonds, based on their interatomic distances and angles, are provided. Statistics are calculated from the highest resolution structures from the PDB, where hydrogens were added with the hydrogens plugin. (Unique structures with resolutions between 0.5-1.6Å, observed R-factors better than 0.25 and free R-factors better than 0.30.)

#### pa

- The *pa* (partial alignment) plugin is used to fit residual dipolar coupling (RDC) and residual chemical shift anisotropy (RACS) data of biomolecules using a Singular Value Decomposition (SVD).
- Supports the refinement of sum couplings, like those of methylenes, with the # wildcard operator. ex: 'CA-HA#'
- Supports the refinement of multiple molecular structures simultaneously with one dataset.
- Includes detailed statistics on the fit for each type of interaction.
- · Identifies outliers based on Grubbs tests.
- Includes 'fixers' to find and fix errors in the sign of RDCs and RACS as well as the exclusion of outliers.
- Reads data from mollib partial alignment files (.pa), NMRPipe DC input files and magnetic resonance data in Xplor-NIH format.
- Supports the automatic fetching of magnetic resonance data from the PDB. (i.e. .mr files) However, only residue numbers are read in at this time.
- Currently includes CSA tensor data for the backbone H, C, and N atoms of proteins. Other nuclei can be easily integrated through a settings file.
- Supports methyl RDC data that have been projected onto C-C (or S-C) bonds, as used in Xplor-NIH.
- Weights the contribution of RDCs and RACS based on relative errors. If errors are not specified, default errors
  are used from the settings.
- Pre-calculated dipolar couplings can be used from the settings, or dipolar couplings can be calculated from the bond lengths and gyromagnetic ratios of the spins from an interaction.
- Interactions are identified using an abbreviated syntax. For example, 14N-H, A.14N-H, 14N-14H and 14N-C-1 are all valid identifiers.
- Alignment files with multiple alignment media datasets can be selected with the --set option.

#### 3.1.5 API Features

The API has the following features and updates.

- Testing Framework. A testing framework that uses pytest, tox and a CLI tester.
- *CLI Tester*. The CLI tester is located in the tests/cli directory, and it is invoked by typing make test-cli in the root project directory. It is also included in the tox tests under the cli environment.
- *Plugin Framework*. A plugin framework to add and remove functionality. The base Plugin is located in the plugins folder.
- Settings Manager. A settings manager to dynamically change settings from the command line or through configuration files.
- *Optimized Functions*. Optimized (Cython) functions to calculate the length of vectors and to find atoms within a distance cutoff located in mollib.core.
- Statistics Plugin. A statistics plugin to calculate statistics and datasets over high-resolution structures.

# CHAPTER 4

# Development

The following are instructions for locally developing a branch of mollib.

- 1. Checkout. First, checkout the branch using git.
- 2. Build Cython Extensions. The Cython and C extensions can be compiled in place.

```
$ make inplace
```

3. Build Datasets Build and compute the datasets. This may take a few hours.

```
$ make build-data
```

4. Build Documentation Build the documentation in html format under docs/

\$ make docs

\$ make test

**Note:** You will need to have sphinx, sphinxcontrib-napoleon, latex and latexmk installed.

5. **Test the Build** Run the package's tests.

**Note:** You will need nosetests to run the tests.

Alternatively, mollib can be tested against multiple platforms using tox.

\$ make test-all

6. **Install in Developer Mode**. Install the package in developer mode. This adds the package's source path to the python path. Edits to the source path are reflected in the global script.

```
$ make develop
```

If you'd like to uninstall the develop mode, use the following command.

```
$ python setup.py develop --uninstall
```

# 4.1 Testing

Mollib includes 4 different kinds of tests. These are all executed by the make test-all command.

- 1. **Pytests and unitests**. These are tests stored in the tests directory. They are run automatically by executing one of the following:
  - a. pytest
  - b. make test
  - c. make test-all
- 2. **Docstring tests**. These are tests within the docstrings of functions, classes and methods in the mollib source (mollib subdirectory). These tests are run automatically by executing one of the following:
  - a. pytest
  - b. make test
  - c. make test-all
- 3. **Tox**. All of the pytests, unittests and doctests are tested in each Python environment using tox. These tests are run automatically by executing one of the following:
  - a. tox
  - b. make test-all
- 4. **CLI tests**. These tests detect changes in the output text from a specific set of command arguments and mollib. These tests are located in tests/cli directory. An error will be flagged if the output of a mollib command has changed from the contents of the .txt file. The output of the commands are also used in the documentation within the .rst files. These tests are run by executing:
  - a. make test-cli
  - b. Additionally, if the output of a command changes, the reference commands can be reset by entering the tests/cli directory and typing make clean&&make build. The changed .txt and .rst files should be committed to the repository.
  - c. New commands can be created by typing the command in a .sh file and making this file executable.

# 4.2 Makefile Options

The make command contains a number of commands to setup and develop mollib. The make commands are listed by typing make help.

Datasets are included in the mollib/data directory. Data files should be included in the MANIFEST. in file.

# 4.4 Adding Plugins

Adding plugin modules may require the registration of the plugin, the registration of the plugin's settings or both.

To register a plugin, add the following to the root \_\_init\_\_.py file for the plugin:

To register a plugin's settings, add the following to the root \_\_init\_\_.py file for the plugin:

### 4.5 Branches

Mollib uses git-flow to organize branches. These are the main branches:

- 1. **master**. The master branch is the default branch, and it contains the *production* code. It should pass all tests including travis-ci tests.
- 2. **development**. The development branch is used to accept new features, hotfixes and releases. It should pass all tests including travis-ci tests.

# 4.6 Docstring Format

Docstrings follow the numpy style. There are a few additional guidelines:

- 1. dict parameters and return values should list the expected keys/values
  - a. dict parameters should list the key and value types using 'key' and 'value' in bold. If known, the object type should be listed after the description.

# **Building and Deployment**

# 5.1 Building

Platform specific distributions are needed because mollib includes C extensions written in Cython. These extension must be compiled using a compiler for each type of operating system.

The build and install distribution packages, the following packages are needed:

• Cython 0.25+

### 5.1.1 Linux Distributions (Python Wheels)

Compile and build a Python wheel package.

```
$ python setup.py bdist_wheel
```

The Python wheel can be installed using pip.

\$ sudo pip install <package\_file.whl>

### 5.1.2 Mac OS X Distributions (mpkg)

1. Upload the source distribution

```
$ python setup.py sdist upload
```

2. Upload a binary distribution

$ python setup.py bdist_wheel upload
```

2. Compile and build a Mac OS X package (.mpkg) file.

The .mpkg file can be installed by dragging it into the Applications folder.

# 5.2 Deployment

The linux and osx packages are built using the mollib-wheels repository. Follow these steps to create a new release.

- 1. **mollib repository**. Tag a new release on the mollib *master* branch and bump the version in the mollib/\_\_version\_\_.py file.
- 2. **mollib-wheelhouse**. Update the BUILD\_COMMIT in the .travis.yml to point to the new mollib tag. If needed, switch the twine repository to the test servers.
- 3. Push the sdist to PyPi.


